Accommodation.

Arrival day is Thursday 12 December 2024

Competition costs

The organizer is not covering accommodation, traveling costs of delegations, not any other expenses made during the stay. <u>Start fee per 1 individual gymnast – $70 \in$ </u>

Please make the participation fee payment based on the invoice sent by Gymnastics Club Nord at least 5 days before the start of the competition. It is also possible to pay in cash on site (one representative per team).

Cancellation of registered gymnast's participation:

Until December 1, 2024 (23:59) - 100% exemption from the participation fee. Starting from December 2, 2024 (00:00) - the participation fee will not be refunded, except as provided in point 6.4* of the Estonian Gymnastics Federation operating procedure.



*According to point 6.4 of the Estonian Gymnastics Federation operating procedure, the refund of the participation fee for a non-participating gymnast/group is possible only based on a medical certificate. In this case, the organizer is obligated to refund at least 50% of the participation fee.

Fee for missing judge - 100

Each club must provide two judges who have completed rhythmic gymnastics training and hold a valid FIG or National-issued judge license. Please register the judges in RGForm. Registered judges must be present until the end of the competition. In case of a judge's absence, a fine of €100 will be imposed.

Hotel - You need to book hotel by yourself. There is a hotel near the sports hall just 3 minutes by walk -

All costs have to be paid upon arrival.

The teams, who leave the competition before the end and will not be on the award ceremony, will be removed from the competition. Their results will be cancelled.

Transport.

Organizer will provide transportation for your delegation from Tallinn Airport to the hotel and back.

Transfer - 10 EUR per person (Tallinn Airport-Hotel-Tallinn Airport)

Insurance.

All delegations are responsible for having the necessary coverage against accidents and illness.

RANKING AND AWARDING

Individual rankings will be determined in all age categories by birth year. Gymnasts who place 1st to 3rd in individual events will be awarded medals. In case of a tie in points, the ranking of gymnasts will be determined based on the current FIG rules.

Program:

Thursday 12th December - Arrival of the delegations, training is not possible Friday 13th December - Technical meeting, all-round competition level B/A Saturday 14th December - Technical meeting, all-round competition level B/A Sunday 15th December - Technical meeting, all-round competition level A Monday 16th December - Departure of the delegations.

By registering for the competition, gymnasts, coaches, judges, and volunteers automatically grant permission for visual materials of themselves to be published (photos, videos). If an individual does not agree to the display of their personal data and visual materials, they must inform the competition organizer and the sports association in writing no later than the start of the competition.



Recording videos and taking photos with professional equipment is allowed only for accredited journalists and photographers (registration at <u>https://</u><u>rgform.eu/event.php?id_prop=6056</u>). Restrictions do not apply to the use of mobile phones and other smart devices for photography and filming.

DOPING AND SPORTS SAFETY: Every registered athlete must be prepared for doping control. Refusal to undergo doping control or evading doping control will be considered a violation of anti-doping rules. Athletes, coaches, and judges are required to follow fair play, anti-manipulation of sports events, and sports safety rules (https://www.eevl.ee/sporditurvalisus/).
