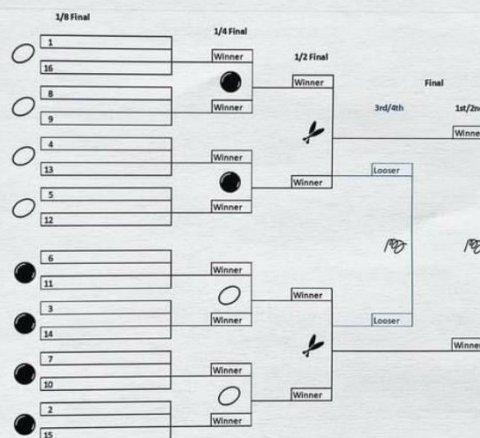

VISA

Please verify immediately with your travel agent or the Montenegrin Embassy or Consulate in your country, if a visa is required for your travel to Montenegro. The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before **July 15th** to the LOC.

The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.

INSURANCE

The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.

	<p>Basic insurance (sickness, accident, and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. Delegation members with insufficient insurance cover must inform the LOC in advance.</p> <p>The LOC will subsequently offer insurance at the Federations own charge as follows: 25€ per person/day.</p>
SAFEGUARDING	<p>From the official event day of arrival until the official day of departure, Participants (gymnasts, coaches, judges and any other delegation members) have the possibility to contact by phone or e-mail the LOC Safeguarding Officer in case of harassment and abuse of any type or if they are worried and do not feel comfortable.</p> <p>The information regarding the LOC Safeguarding Officer will be communicated upon arrival of the delegations on site.</p> <p>In addition, posters of the “10 Golden Rules of Gymnastics”, the FIG campaign to raise awareness about youth protection in Gymnastics, will have to be displayed in several locations, including training and warm-up halls and public zones.</p>
INTERNATIONAL TRANSPORTATION	<p>The invited participating federations must pay for the travel costs of their delegation members</p> <p>The Travel Schedule Form must be returned to the LOC by August 20th</p>
LOCAL TRANSPORTATION	<p>The LOC will provide free-of-charge local transfers “airport – hotel –airport”</p> <p>Airports: Tivat (MNE), Podgorica (MNE)</p> <p>and “hotel – gym – hotel” for all accredited delegation members.</p>
ACCOMMODATION	<p>The Following prices are per person, per night and include:</p> <ul style="list-style-type: none"> - Accommodation - Meals (breakfast, lunch and dinner) - Transportation <p><u>HOTEL SLOVENSKA PLAZA ****</u> Single room: 130 € Double room: 100 €</p> <p><u>HOTEL SLOVENSKA PLAZA ***</u> Single room: 115 € Double room: 95 €</p> <p>The invited participating federations or clubs must pay for accommodation and meals expenses of their delegation members.</p> <p>The prices charged for the hotel rooms will not exceed the usual hotel rates. While the Accommodation Form must be uploaded by August 20th. at the very latest, the costs for the accommodations must be paid to the LOC as follows:</p> <ul style="list-style-type: none"> - at the time of the Definitive Entry (July 15th.) 50% of the accommodation costs. - at the time of the Nominative Entry (August 20th.) the remaining 50% of the accommodation costs. <p>Cancellation/Reimbursement Policy: 30% of the total accommodation costs are refundable in case of cancellations at least 1 month prior to the event (July 15th) For cancelations made after July 15th there will be no reimbursement.</p>
MEALS	<p>All the delegation members who booked their accommodation through the LOC will have all meals included in the accommodation price.</p> <p>Breakfast, Lunch and Dinner will be served at the hotel, except the lunch for judges, who will be served in the Competition Venue, during the competition days.</p>
