Music durations: Duo max 1:45, Trio max 2:00.</p> <p>The organizer reserves the right to make changes in age categories and apparatus if it turns out that there are not enough participants or there are too many.</p>

RANKING AND AWARDING	Individual rankings will be determined in all age categories by birth year. Gymnasts who place 1st to 3rd in individual events will be awarded medals. In case of a tie in points, the ranking of gymnasts will be determined based on the current FIG rules.
PARTICIPATION FEE AND FINANCES	<p>The participation fee:</p> <ul style="list-style-type: none"> • Individual 65 € per gymnast • Duo 30 € per gymnast, 60 € per group • Trio 30 € per gymnast, 90 € per group <p>Please make the participation fee payment based on the invoice sent by Gymnastics Club Crystal at least 5 days before the start of the competition. In case the participation fee is not received at least 2 days before the start of the competition, the gymnast will be allowed to compete only upon payment of 1.5 times the participation fee, either by transfer (when submitting a payment order).</p> <p>Cancellation of registered gymnast's participation: Until October 2, 2024 (23:59) - 100% exemption from the participation fee. Starting from October 3, 2024 (00:00) - the participation fee will not be refunded, except as provided in point 6.4* of the Estonian Gymnastics Federation operating procedure.</p> <p><i>*According to point 6.4 of the Estonian Gymnastics Federation operating procedure, the refund of the participation fee for a non-participating gymnast/group is possible only based on a medical certificate. In this case, the organizer is obligated to refund at least 50% of the participation fee.</i></p>
JUDGES	<p>Names of delegation - September 19</p> <p>Each club must provide two judges who have completed rhythmic gymnastics training and hold a valid FIG or Estonian-issued judge license. Please register the judges in RGForm. Registered judges must be present until the end of the competition. In case of a judge's absence, a fine of €100 will be imposed.</p>

Late registrations will be accepted only upon payment of double participation fees.</p> <p>Named delegation: September 19, gymnasts, coaches</p> <p>Music upload: October 12 (only in mp3 format)</p>

Additional information regarding the organization of the competition will be sent to participants no later than one week before the start of the competition.

The personal data of registered gymnasts, coaches, judges, and volunteers will be used for the publication of competition results in the competition protocol, rgform.eu, or other competition software, on the sports association and/or organizer's website, and on social media channels.

By registering for the competition, gymnasts, coaches, judges, and volunteers automatically grant permission for visual materials of themselves to be published (photos, videos). If an individual does not agree to the display of their personal data and visual materials, they must inform the competition organizer and the sports association in writing no later than the start of the competition.

Recording videos and taking photos with professional equipment is allowed only for accredited journalists and photographers (registration at https://rgform.eu/event.php?id_prop=4978). Restrictions do not apply to the use of mobile phones and other smart devices for photography and filming.

DOPING AND SPORTS SAFETY: Every registered athlete must be prepared for doping control. Refusal to undergo doping control or evading doping control will be considered a violation of anti-doping rules. Athletes, coaches, and judges are required to follow fair play, anti-manipulation of sports events, and sports safety rules (<https://www.eevl.ee/sporditurvalisus/>).
