PERSONAL DATA PROTECTION	<p>Personal information of registered gymnasts, coaches, judges, and volunteers are used in published official competition protocols, rgform.eu online environment, competition's/federation's website and in social media channels. By registering to the event, the gymnasts, coaches, judges, and volunteers are giving a consent to publish visual materials (photos, videos) on which they might be displayed. In case the person is not consent with the previous, LOC and federation hast to be informed in written form by the start of the competition. Only photographers and journalists with accreditation are allowed to take pictures and film the event. (Registering via rgform.eu or onsite).</p>
