**Individual Competition:**

The individual rankings will be determined in all age groups based on birth years. Those who win 1st to 3rd place will receive medals and diplomas, while all participants will receive gifts.

For individual apparatuses, gymnasts who achieve 1st to 3rd place will be awarded medals. In case of tie scores, the ranking of gymnasts will be decided in accordance with current FIG rules.

**ENTRY FEES AND  
FINANCES**

The entry fee per individual gymnast is **60€**.

Please ensure the entry fees are paid according to the invoice sent by Irina Kikkas Gymnastics Club at least 5 days before the beginning of the competition. If the entry fee is not received at least 5 days before the start of the competition, the gymnast will only be permitted to compete upon payment of 1.5 times the entry fee, either through bank transfer (by submitting a payment order) or in cash on-site.

In case of cancellation:

- Until 24th November 2024 - 100% refund of the entry fee
- From 1st December 2024 onwards - no refund of the entry fee, except as provided in point 6.4 of the EEVL operational rules.

\*In accordance with point 6.4 of the EEVL operational rules, the entry fee can only be refunded by the organiser in case a gymnast does not participate due to a medical certificate. In this case, the organiser is obliged to refund 50% of the entry fee.

**JUDGES**

**Judges' names should be submitted by 8th November 2024.**

Each club must provide 1-2 rhythmic gymnastics judges. Judges must be present throughout the competition. If a judge is absent, a fee of 100€ per judge will be charged.

Please submit judges' names through the online system at [www.rgform.eu](http://www.rgform.eu). Only judges with valid FIG or locally issued judge's licenses in Estonia are eligible for evaluation.

<b>ACCREDITATION</b>	<p>Accreditation will take place 1 hour before the beginning of the competition.  Changes to submissions can be made up to one hour before the start of the competition.</p>
<b>SCHEDULE</b>	<p>The approximate schedule will be available 5 days before the beginning of the competition.</p>
<b>ADDITIONAL INFORMATION</b>	<ul style="list-style-type: none"> <li>➤ The personal data of registered gymnasts, coaches, judges, and volunteers will be used for the publication of competition results in the competition protocol, <a href="http://www.rgform.eu">rgform.eu</a> platform, on the sports association and/or organiser's website, and on social media channels.</li> <li>➤ When registering for the competition, gymnasts, coaches, judges, and volunteers automatically give consent for the use of visual materials depicting them (such as photos and videos). If an individual does not wish to have their personal data and visual materials displayed, they must inform the competition organiser and the sports association in writing no later than the start of the competition.</li> <li>➤ Taking videos and photos using professional equipment is allowed only for accredited journalists and photographers (registration at <a href="http://www.rgform.eu">http://www.rgform.eu/</a> or on-site). There are no restrictions on using mobile phones and other smart devices for photography and filming.</li> <li>➤ DOPING: Every registered athlete must be prepared for doping control. Refusal or avoidance of doping control will be considered a violation of doping regulations.
