ENTRY FEES	The Entry fee: Group consisting of 1-6 nominated gymnasts and including max 2 coaches 130.00 EUR Group consisting of 7 or more nominated gymnasts and including max 3 coaches 150.00 EUR Extra accreditations: Over the limit of Delegation numbers will be accepted with additional payments which will be confirmed later. Points to note: Please note the additional charge for the group registrations after the deadline is 100 EUR per group (to the LOC). The organizer will send you the invoice after the deadline. The participating Delegation is responsible for covering all bank fees in connection with the bank transfers. The entry fee is NON-REFUNDABLE. Cancellation of registered group's participation: Until November 22, 2024 (23:59) - 100% exemption from the participation fee. Until November 27 2024 (23:59) - 50% exemption from the participation fee Starting from November 28 2024 (00:00) - the participation fee will not be refunded, except as provided in point 6.4* of the Estonian Gymnastics Federation operating procedure.		
	*According to point 6.4 of the Estonian Gymnastics Federation operating procedure, the refund of the participation fee for a non-participating gymnast/group is possible only based on a medical certificate. In this case, the organizer is obligated to refund at least 50% of the participation fee.
